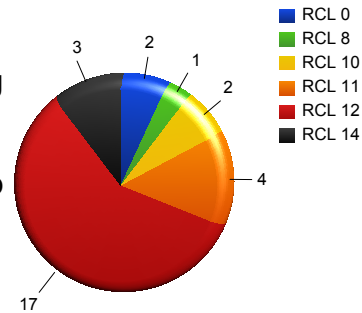
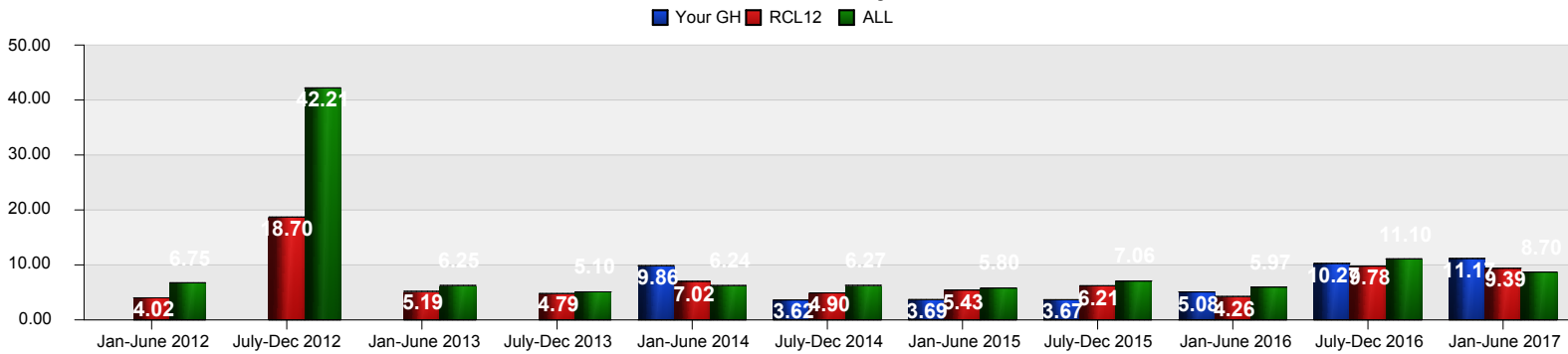


BACKGROUND INFORMATION

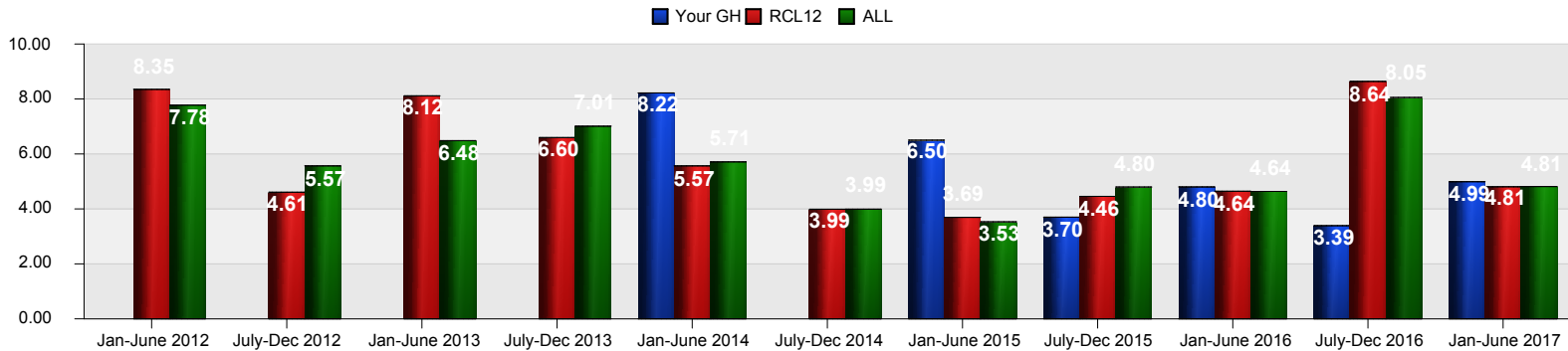

The participating group homes represented several counties in California - both Northern and Southern. The charts below represents a summary of data collected during the period of and compares it with data from past reporting periods. Each chart shows your group home's performance in blue, the performance of your closest comparison group in red (in your case, other **RCL 12** programs) and the average performance of all participating group homes in green.

RESTRAINT SUMMARY:

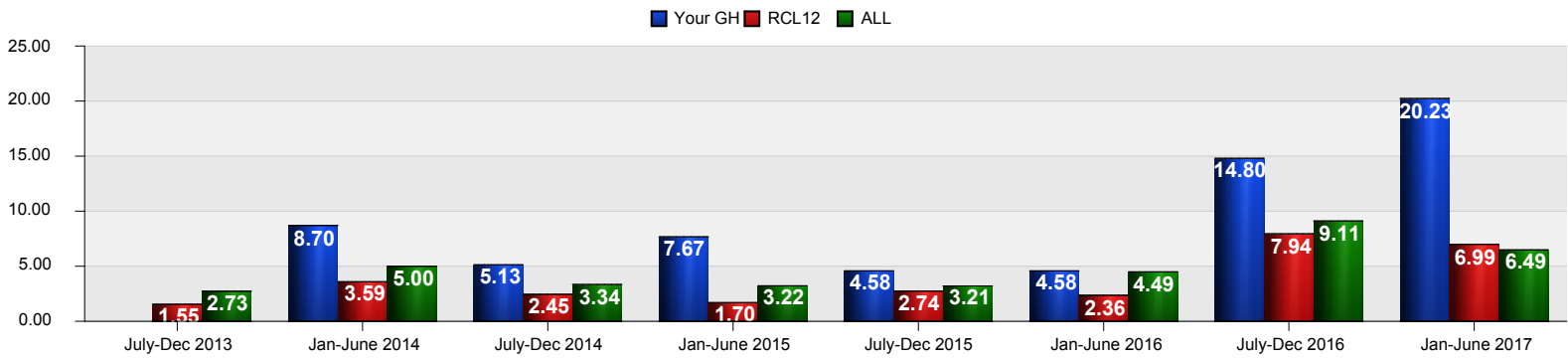
Restraints

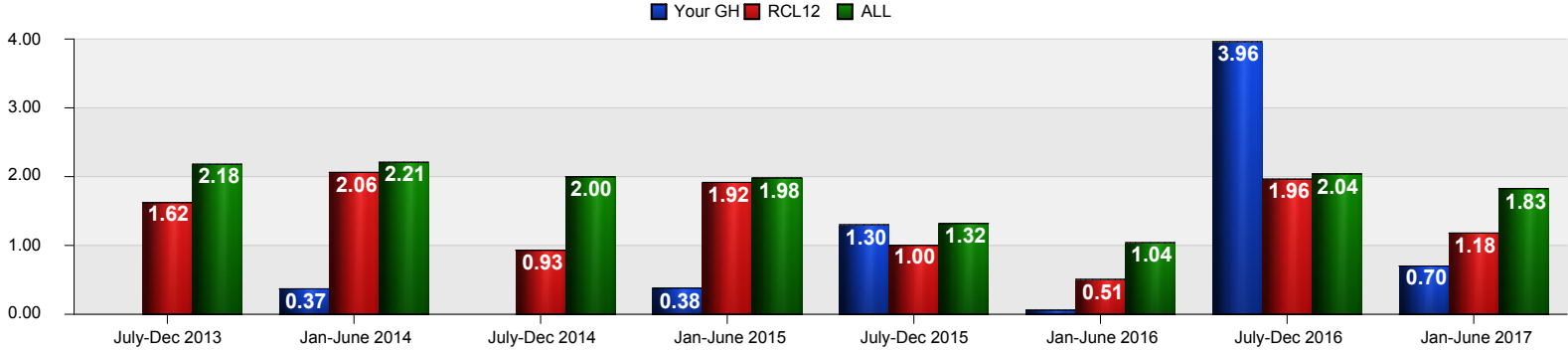
Average Length of Restraints

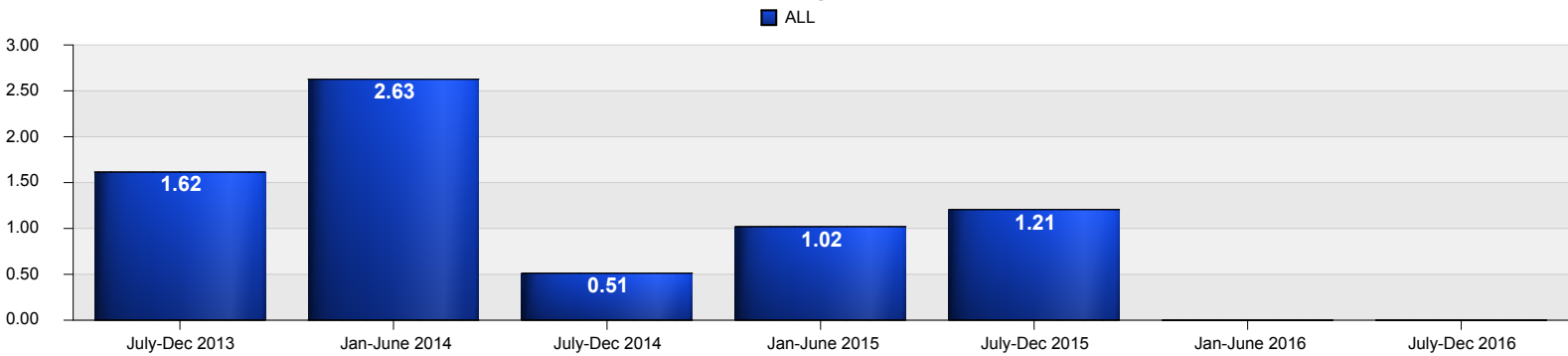

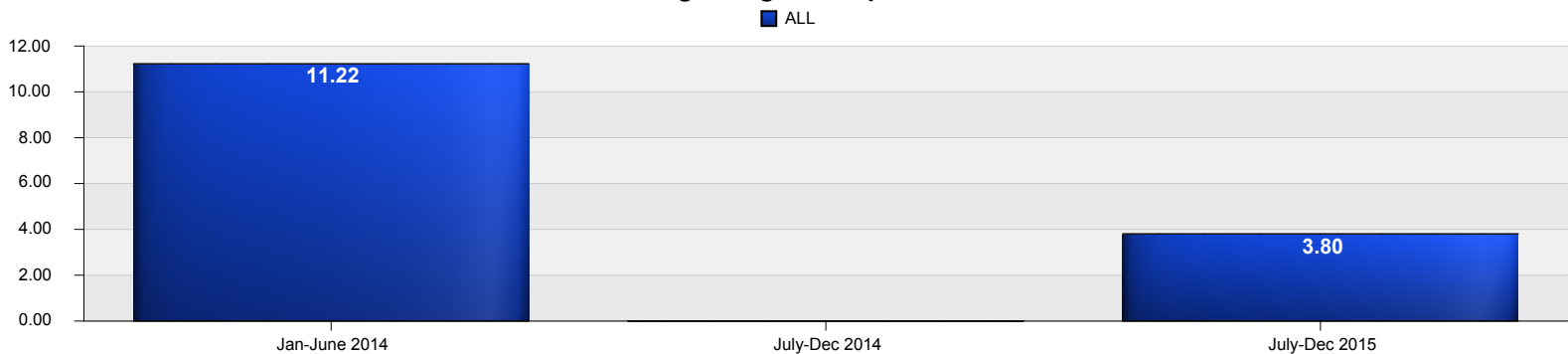
Average Length of Escorts

Protective Separation

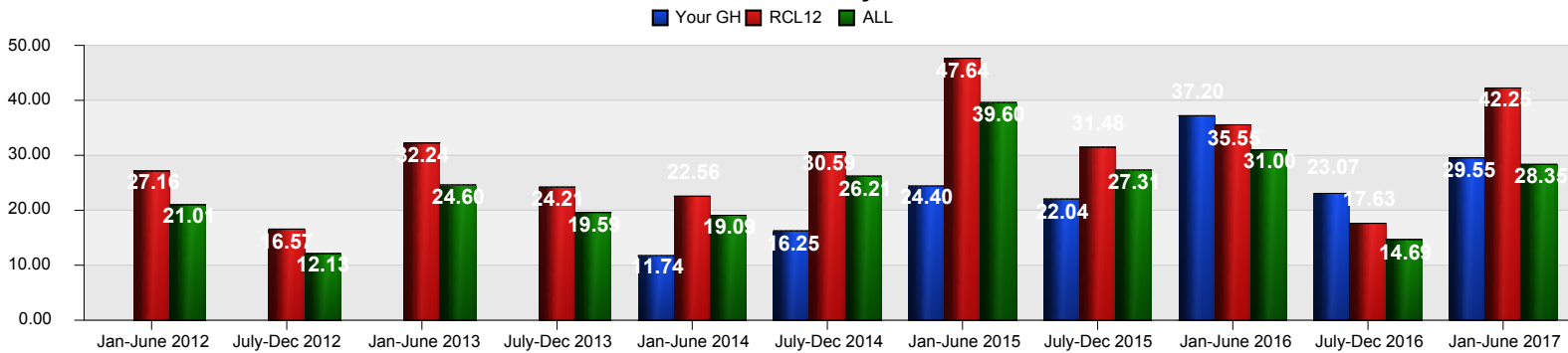


Average Length of Separation

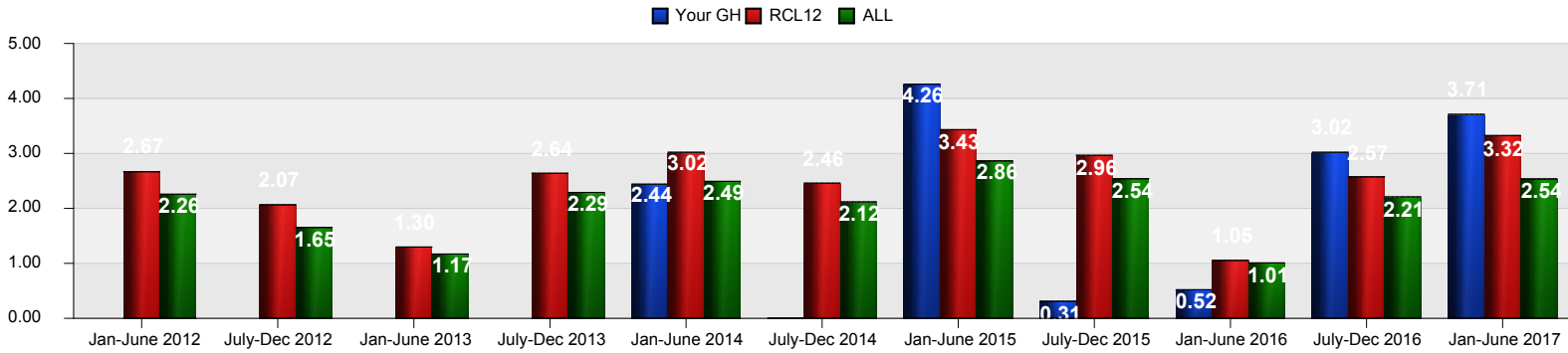
AWOL Per 1000 Day Beds

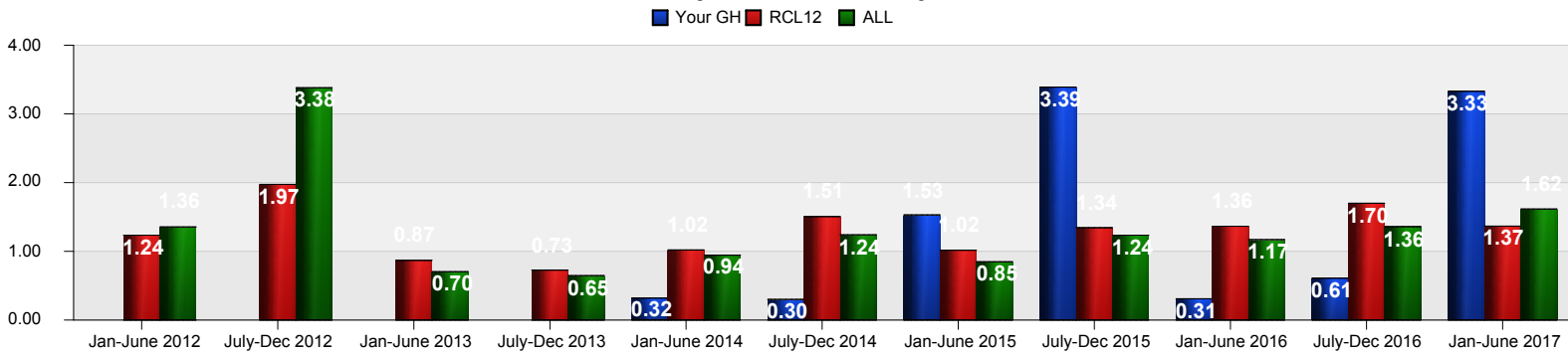
Self Harm Threats Per 1000 Day Beds

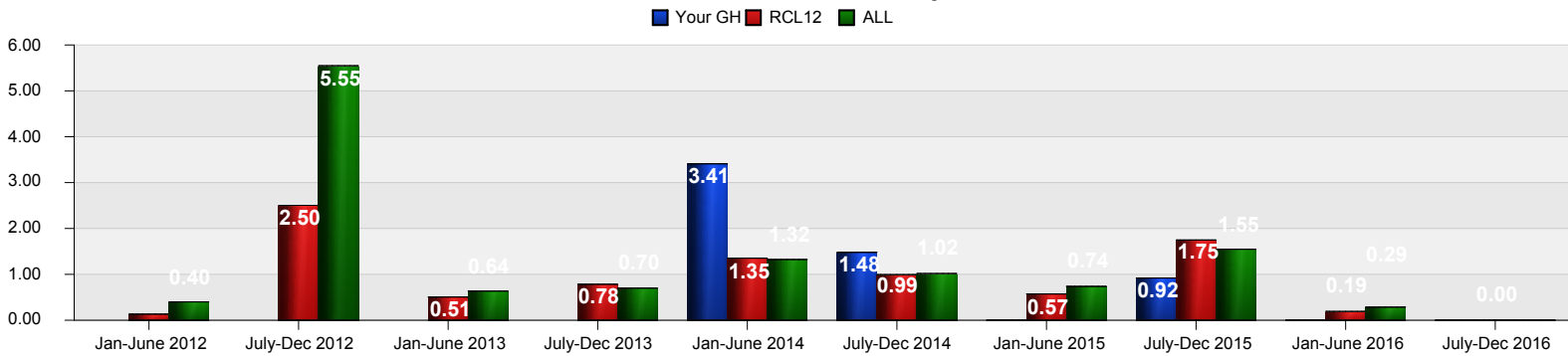
Serious Injuries Per 1000 Day Beds



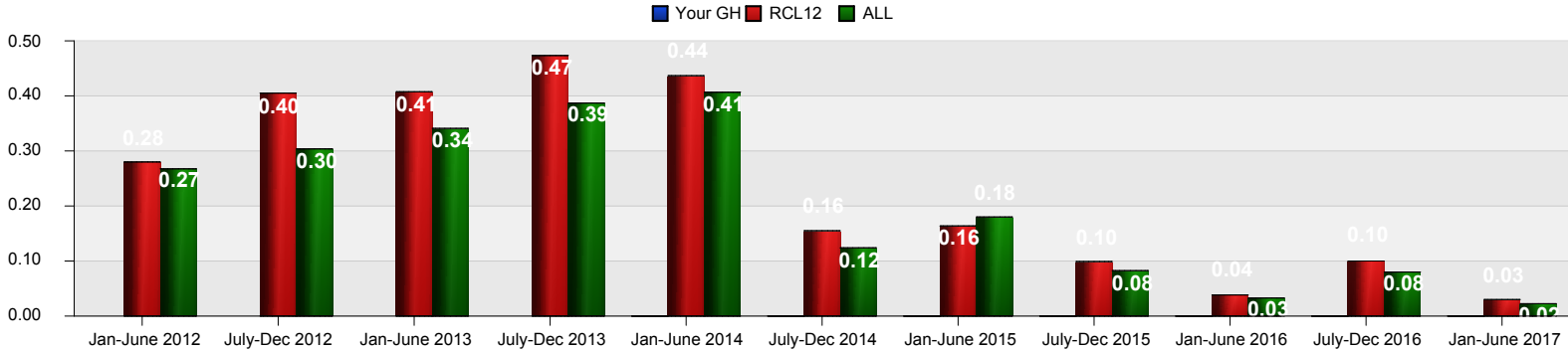
SERIOUS INJURIES SUMMARY:

Medication Errors Per 1000 Day Beds



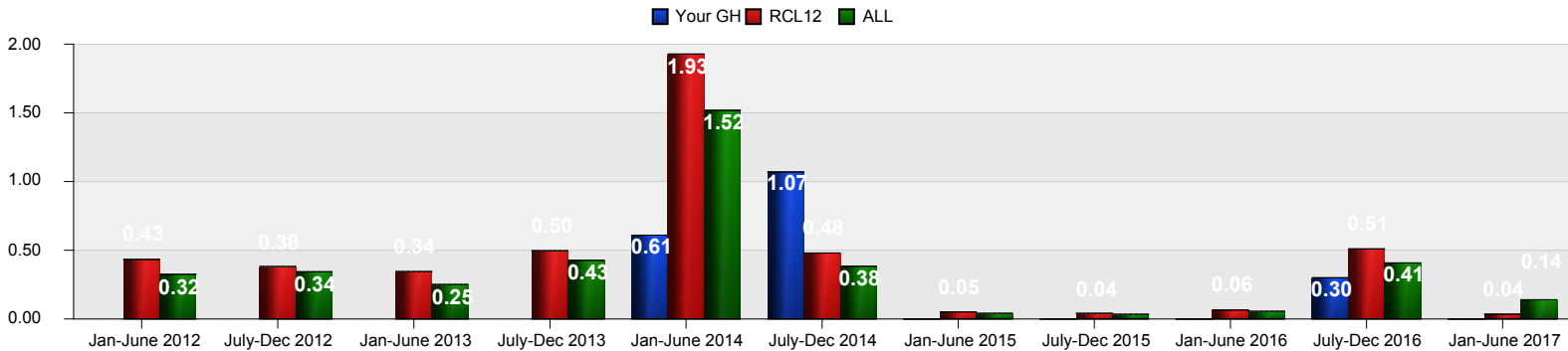
CCL Type A Citations Per 1000 Day Beds

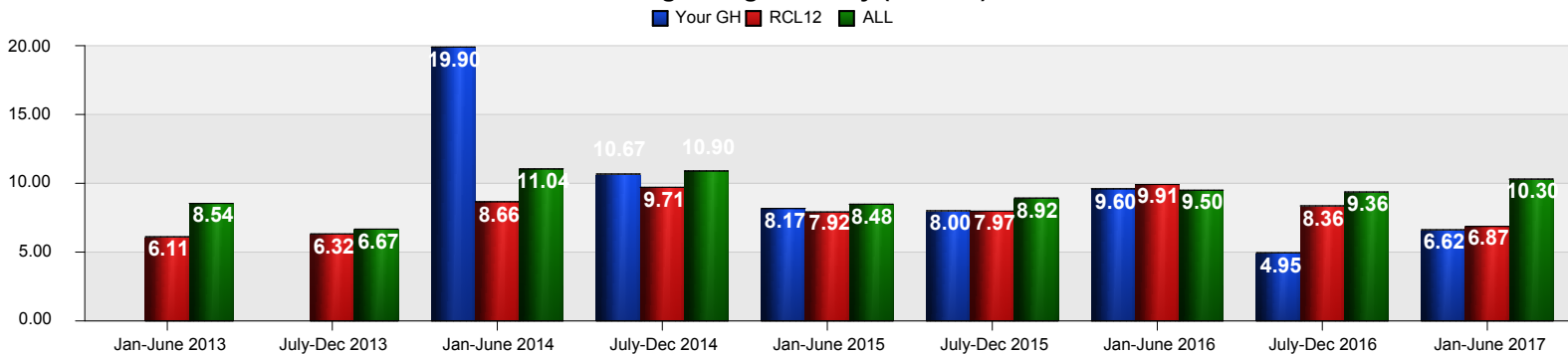
CCL Type B Citations Per 1000 Day Beds

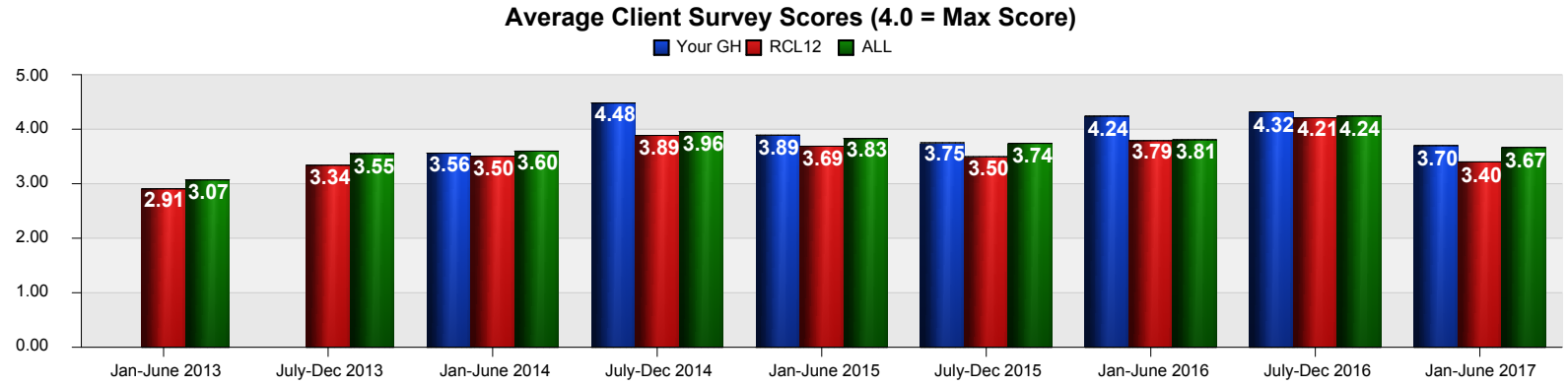
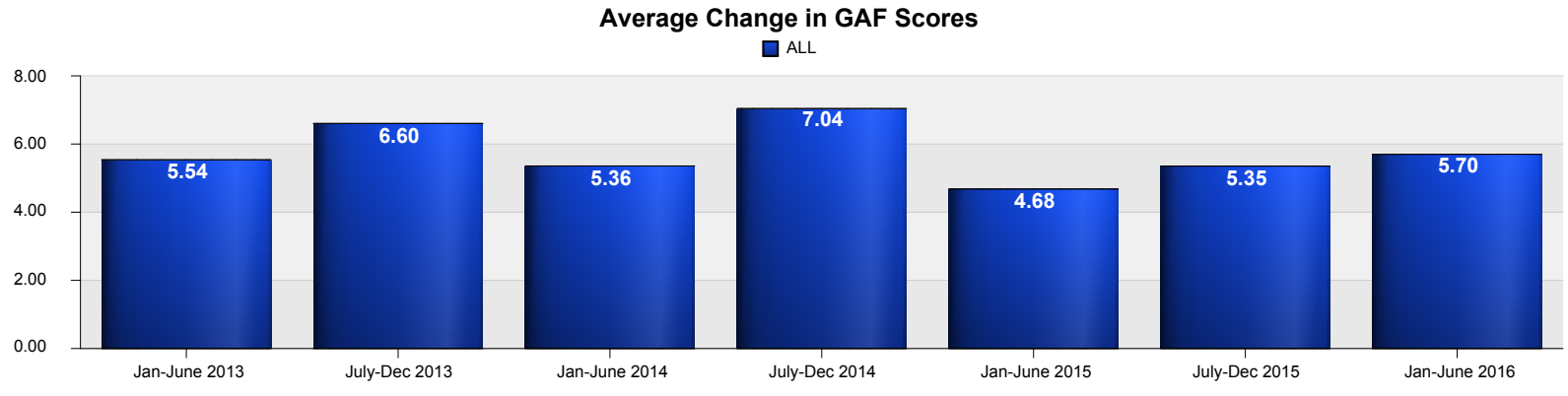

Average Length of Stay (Months)



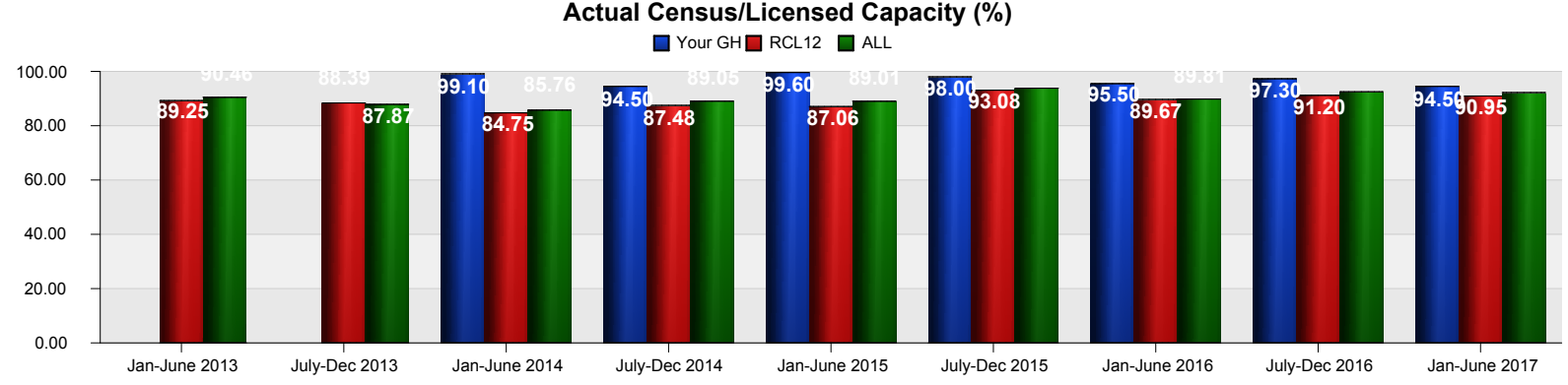
AVERAGE LENGTH OF STAY SUMMARY:

AVERAGE CLIENT SURVEY SCORES SUMMARY:

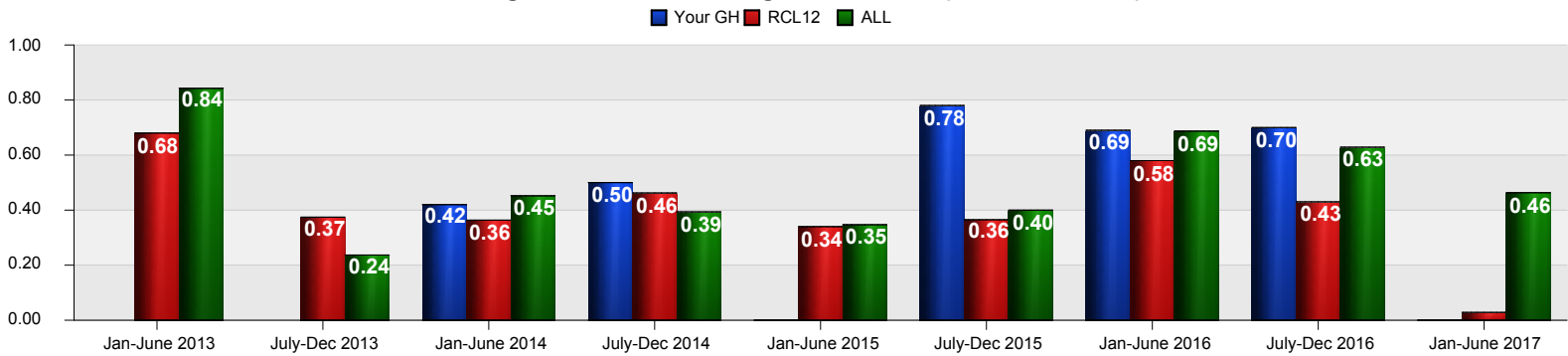

Your group homes percentage of licensed capacity was higher than the comparison group. Also, note that your group homes percentage of licensed capacity was higher than the entire group.

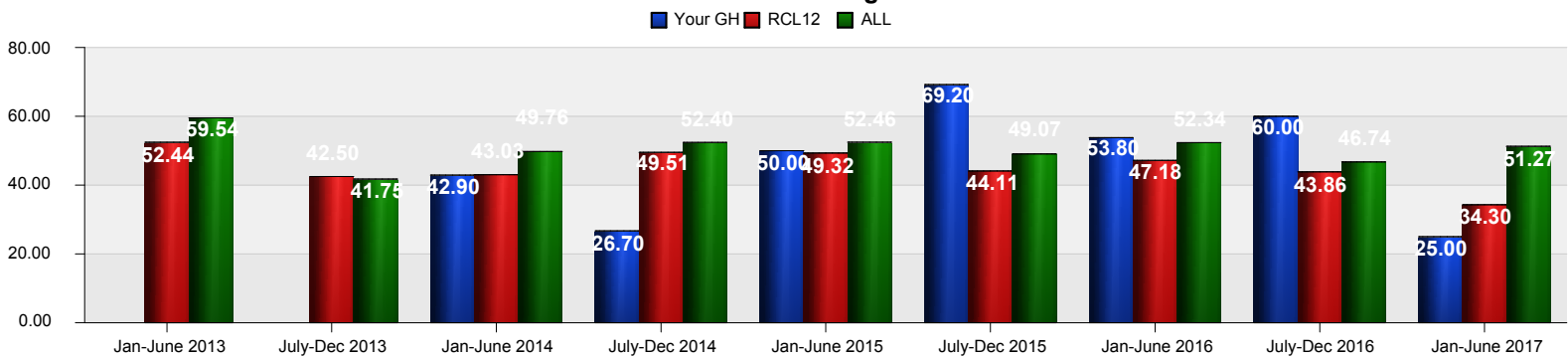
Average Score Per Discharge Destination (Max Score =2.0)



DISCHARGE DESTINATION SUMMARY:

Discharge destination is measured as follows: Most Desirable (2 Points; Family or Independent Living), Desirable (1 point; Foster Home, Lower Level Group Home, etc.), Neutral (0 Points; Same RCL), Less Desirable (-1 Point; Higher RCL or Emergency Shelter), Least Desirable (-2 Points; Incarceration, Psychiatric Hospital, etc.). **Your group home discharged clients to lower levels of care less often than the comparison group. 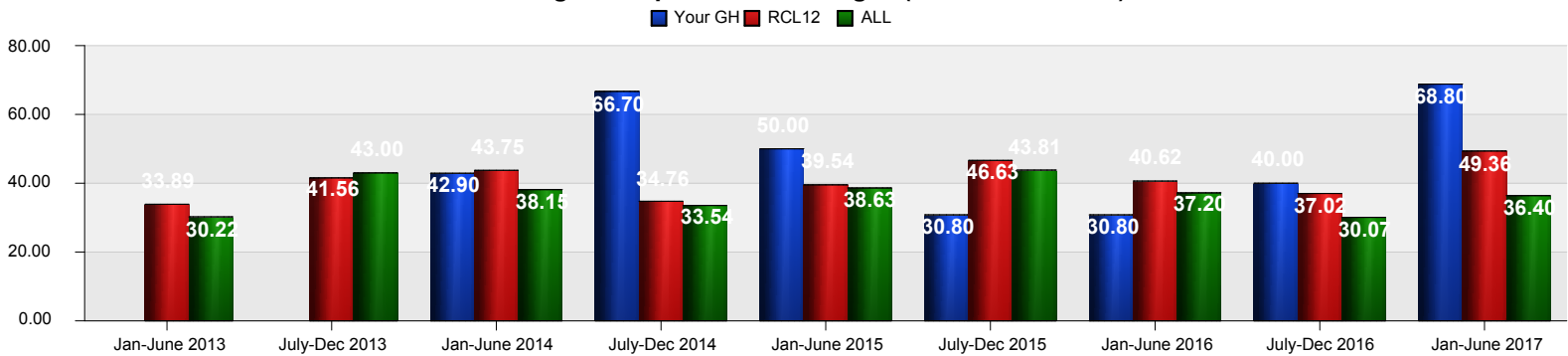
Planned Discharges

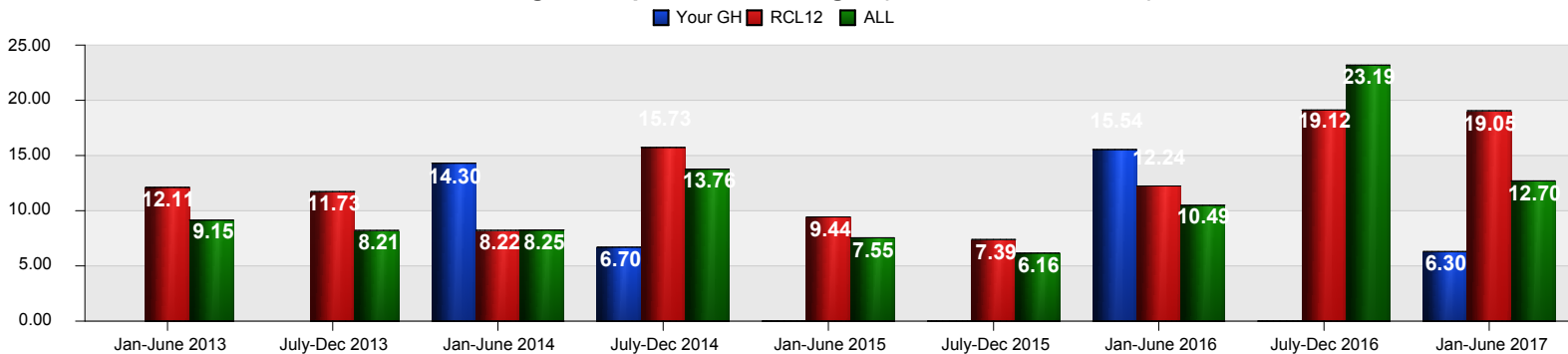
Percentage of Unplanned Discharges (Behavior Related)



UNPLANNED DISCHARGES BEHAVIOR RELATED SUMMARY:

Unplanned discharges, Behavior Related occur when the client has not completed treatment due to running away, needing more intensive services, or incarceration. **Your group homes percentage of unplanned discharges that were behavior related is higher than the comparison group. Please note that your group home's percentage of unplanned discharges that were behavior related is higher than the entire group.**

UNPLANNED DISCHARGES NOT BEHAVIOR RELATED SUMMARY:

Unplanned discharges, Not Behavior Related occur when the client has not completed treatment due to reasons unrelated to his or her behavior, such as the placement was terminated by the parent, guardian, or client, funding source terminated, etc. Your group homes percentage of unplanned discharges that were not behavior related is lower than the comparison group.
